People are more likely to support your fundraising efforts if they know how their money could help. Here are some handy facts about Kangaroos.

- Kangaroos was set up in 1994 by a group of parents of children with special needs. It was originally a Saturday playscheme for six children.
- We now provide year round clubs, activities and trips out for over 300 children and adults with severe learning disabilities, sibling support, family days and parent and carer coffee mornings.

How your fundraising helps

- £25 could pay for an hour of support at one of our clubs for a young person independent of their families, helping them to build confidence and self-esteem.
- £50 could pay for sensory equipment which helps to create a calming and stimulating environment for members, allowing them to explore their senses and engage in activities that promote their overall well-being.
- £100 could pay towards the cost of an accessible minibus enabling wheelchair users to have a fun day out with their friends.
- £500 could pay for a group of young people to visit an outdoor adventure centre for a day, where they can enjoy activities tailored to their needs and enable them to push boundaries.
- £1000 could pay for a family day where families can come together in a safe and supported environment with a range of activities to enjoy.

Fundraising Ideas

QUICK AND EASY IDEAS

Hold a bake sale

Bake for friends, colleagues or school. Sell or ask for donations for your tasty treats.

The Gift of Giving

In celebration of a birthday, wedding anniversary or Christmas - ask people to make donations rather than buy presents or cards. Set up a Just Giving page for your event and people can still leave you a special message whilst donating to a good cause.

Come dine with me

Host a dinner party and charge your guests for their meal.

Pamper party

Invite friends for a manicure or massage and charge per treatment. Why not ask local beauticians to donate time or products?

How about a sweepstake?

If there's a major sporting event coming up, hold a sweepstake to make it more fun!

Organise a themed event that ties in with an awareness day

How about a garden party in celebration of National Tea day in April, or a fitness fundraiser, fancy dress party, nearly new clothes sale or quiz night.

We love meeting our fundraisers, please contact <u>info@kangaroos.org.uk</u> and we can arrange a convenient date with you to say thank you in person and take some photos to share on our social media.

Don't forget to Gift Aid it! Your donations to Kangaroos could be worth 25% more, as the taxman gives too, at no cost to you! Gift Aid can be applied to any donation made directly by a UK taxpayer, if the amount donated does not exceed the amount of tax paid within that financial year. If you are collecting donations or sponsorship, please encourage supporters who are taxpayers to tick the Gift Aid box on your sponsorship form and collect their full name and address. If you are a UK Tax Payer, Gift Aid cannot be claimed in your name on donations collected from others. Gift Aid should not be claimed when making a donation in return for tickets (raffles, events and auctions) or goods and services, this is because you are 'getting something' in return for your donation.



HOW WE CAN HELP

PROMOTION

Let us know about your fundraising event or activity and we can promote it via our social media pages. Got some photos of your training, activity or event? Let us know and we can share them via our social media pages too.

KEEPING IT SAFE AND LEGAL

Please enjoy your fundraising and have fun but there are a few rules and regulations that you need to bear in mind.

HEALTH & SAFETY

Ensure that your event or activity is organised safely. Identify any hazards and assess any possible risks. Consider whether you need to have a First Aider present.

FOOD

If you are providing or selling food ensure you follow food hygiene procedures. Contact your local council for advice or see food.gov.uk .

LICENCES

Ask your local authority whether you need any special licences e.g. to sell alcohol, for public entertainment.

RAFFLES

If you hold a small raffle on the day of your event you don't need a licence as long as the tickets are sold and the draw is held during your event. If you want more information and advice visit www.gamblingcommission.gov.uk.

INSURANCE

Check what insurance you might need. Kangaroos insurance only covers events we organise and we cannot accept liability for any fundraising activity or event organised by individuals.

COLLECTIONS

Street collections or collections on public property will need to be registered with the local authority. Please seek the permission of Kangaroos before undertaking any collection.
